Cedar River Academy (“CRA”) agrees to enroll the above named student at CRA . I, the undersigned, agree to pay the required tuition and fees as specified below.

**Tuition Payment Schedule (select one by initialing the preferred option):**

- \_\_\_\_\_ Twelve (12) monthly payments of \$870 payable by the first of each month, beginning July 1, 2010.

**Terms and Conditions**

I understand that my obligation to pay the tuition and fees for the 2010-2011 academic year according to the payment schedule selected above is unconditional. I agree to pay all incidental expenses including, but not limited to school supplies, uniforms, and fees for chargeable extracurricular programs. I understand that I will be invoiced for extended services at the rate of \$10 for each fifteen minute period my child is at school before 8:15 AM and after 2:45 for pre-kindergarten students and after 3:45 PM for all other students, unless my child enrolled in a chargeable extracurricular CRA program.

I understand that in signing this Agreement for the coming academic year, I agree to accept the rules and regulations of CRA as stated in the then-current Parent Handbook, announcements, and as referred to above. Furthermore, I agree to the policy of CRA that no student will be permitted to participate in school classes or activities unless all accounts relative to the student have been paid in full.

I acknowledge and agree that my child’s opportunity to attend CRA is contingent at all times upon the child, and all other members of my family, honoring the Tools for Citizenship as espoused by the school and its faculty and as set forth in the Student Handbook.

Tuition excludes any after or before school hours tutoring for my child by CRA staff members. Any such tutoring will be billed at the rate of \$40 for each half hour tutoring session. All tutoring will be authorized by me in writing to CRA before any such tutoring sessions are held.

It is understood that all obligations under this Agreement are to be performed and that all monies to be paid under this agreement are due and payable at CRA offices, 42022 196<sup>th</sup> Avenue SE, Enumclaw, WA 98022; that such monies due from me which are unpaid when due shall bear a late charge of 1.5% per month (18% per annum). If it is necessary to file suit to collect any unpaid balance or to enforce any or all provisions of this Agreement, I agree to pay a reasonable attorney’s fee to be fixed by the court.

I hereby authorize and give full consent to CRA to submit and publish, in whole or in part, any photographs, videos, written extractions, and voice recordings in which the above student appears in school publications, including but not limited to newsletters, advertising, brochures, press releases and the school’s websites or web pages. Further, I hereby permit the school to notify local newspapers of my child’s academic, athletic and other special achievements. CRA may retain student work and reuse it to further its educational mission including, but not limited to, use in conference presentations, teacher training, and as an instructional aid in other classes. I agree that the use of photographs or student work does not constitute a waiver of CRA policies, nor does continued use constitute an agreement to continue the student’s enrollment.

I agree not to solicit any employee of CRA to accept a full-time position with any other employer. In the event that I violate this provision and thereby cause an employee of CRA to accept such a position with another employer, I agree to pay CRA an amount equal to the expense incurred in recruiting and training a replacement for the departed employee.
