Cedar River Academy ("CRA") agrees to enroll the above named student at CRA. I, the undersigned, agree to enroll the above named student(s) at CRA, and agree to the Terms and Conditions of this Agreement.

Tuition Payment Schedule: Ten (10) monthly payments of \$1,400 for the first student, plus \$1,260 for each additional student, payable by the first of each month, beginning August 1, 2011. Such Tuition represents compensation for CRA services for all or any part of the following month.

Terms and Conditions

I understand my obligation to pay the tuition and fees for the 2011-2012 academic year according to the payment schedule above. I agree to pay all incidental expenses including, but not limited to school supplies, uniforms, and fees for elective programs. I understand that I will be invoiced for extended services at the rate of \$10 for each fifteen (15) minute period my child is at school before 8:15 AM and after 2:45 for pre-kindergarten students and after 3:45 PM for all other students. Tuition excludes any after or before school tutoring services provided for my child by CRA staff members. Any such tutoring will be billed at the rate of \$40 for each half hour tutoring session. All tutoring services will be authorized by me in writing to CRA before any such tutoring sessions are held.

I understand that either party may terminate this agreement at any time, with or without cause, having given the other party thirty (30) days prior written notice of intent to terminate. All amounts due CRA shall be due and payable immediately upon any such termination.

I understand that in signing this Agreement, I agree to accept the rules and regulations of CRA as stated in the then-current Parent Handbook. Furthermore, I agree to the policy of CRA that no student will be permitted to participate in school classes or activities unless all accounts relative to the student have been paid in full.

It is understood that all obligations under this Agreement are to be performed and that all monies to be paid under this agreement are due and payable at CRA offices, 42022 196th Avenue SE, Enumclaw, WA 98022; that such monies due from me which are unpaid when due shall bear a late charge of 1.5% per month (18% per annum). If it is necessary to file suit to collect any unpaid balance or to enforce any or all provisions of this Agreement, I agree to pay reasonable attorney's fees.

I hereby authorize, and give full consent to CRA to submit and publish, in whole or in part, any photographs, videos, written extractions, and voice recordings in which the above student(s) appear(s) in school publications, including but not limited to newsletters, advertising, brochures, press releases and the school's websites or web pages. Further, I hereby permit the school to notify local newspapers of my child's academic, athletic and other special achievements. CRA may retain student work and reuse it to further its educational mission including, but not limited to, use in conference presentations, teacher training, and as an instructional aid in other classes. I agree that the use of photographs or student work does not constitute a waiver of CRA policies, nor does continued use constitute an agreement to continue the student's enrollment.

I agree not to solicit any employee of CRA to accept a full-time position with any other employer. In the event that I violate this provision and thereby cause an employee of CRA to accept such a position with another employer, I agree to pay CRA an amount equal to the expense incurred in recruiting and training a replacement for the departed employee.

I certify and acknowledge that I have carefully read all of the provisions of this Agreement and that I understand and will faithfully comply with such provisions.
